Project goal(s) (incl. the contribution to the social transformation process in Estonia)

The *main goal* is to prevent the human trafficking in North-East- and North Estonian regions by raising awareness and educating government officials, teachers and other relevant actors in the field of issue of human trafficking beings.

The purposes of the project are:

- to raise awareness on the issue of trafficking in persons as well as on the risk and consequences of illegal job abroad in North-East- and North Estonian regions;
- to educate and prepare social workers and police officers, school psychologists and custom guard officials will be able to work on problem of trafficking;
- to develop network and cooperation between authorities and NGOs in North-East and North Estonia;
- to drag attention of authorities and community to trafficking issues in human rights framework.



Target group

The *direct target group* is government officials, social workers, teachers and other relevant actors in the field of issue of human trafficking beings in the North-East- and North Estonian regions.

The *indirect target group* is Estonian population in general.

For the realization of the project LFT selected and assigned an project leader and trainer – *Mrs Liliya Ivanchenko* and project assistant and trainer – *Ms Olena Valdenmaiier*.

Mrs Ivanchenko and Ms Olena Valdenmaiier together with head of organization Ms Sirle Blumberg prepared the informational materials for participants of the seminar and general



population in Estonia. The head of the LFT *Ms Sirle Blumberg* is responsible for realization of all the project's activities and allocation of the project's funds.

The results of the activity are the following:

A. Two 2-day training-seminars for social workers and psychologists, police-officers and custom guard officials, public prosecutors, teachers, service workers (care and supports for trafficked persons) involved in prevention and fight against trafficking in

human beings in Narva and Tallinn were organized and carried by trainers from LFT and other actors; (see Annexes)

- B. Training-seminar materials, curriculum and information folders for each participant of the seminar were developed;
- C. 1000 small informational cards in Estonian and Russian focusing on prevention of trafficking for people going abroad produced by LFT; (see Annex)
- D. Cooperation and network among different local governmental institutions and NGOs in order to increase their awareness of the problem and promote assistance to victims of trafficking were established and developed;
- E. Over 750 LFT's cards and 100 posters on prevention of human trafficking were distributed by the LFT's team.


Staff of NGO Living for Tomorrow has the most complete up-to-date knowledge and experience on prevention and educational work among professionals.

A. Organization of two 2-day training-seminars

NGO Living for Tomorrow organized and implemented two 2-day training-seminars

"Prevention on human trafficking beings and mechanisms of protection for victims" for social workers and psychologists, police-officers and custom guard officials, public prosecutors, teachers, workers of services (care and supports for trafficked persons) involved in prevention and fight against trafficking in human beings in Narva and Tallinn were organized and carried.

The aim of the training-seminar was to prevent the human trafficking in North-East- and North Estonian regions by raising

language was conducted in year 2007. LFT has really good network to spread the information to the target group. Interest of potential participants to take part at trainingseminars was very great. Amount of received application forms from professionals was more then 2 times bigger than amount of participants that could be by the project. First training-seminar was conducted on January 29 and February 5, 2010 at building of Narva Youth Centre in Northern Virumaa. Second

training-seminar was held on March 12 and 19, 2010 at the hotel Portus in Tallinn. In total 45 participants take part in the both seminars (Narva – 22 and Tallinn – 23). (see Annexes).

Participants had possibility to evaluate every training-seminar. Average evaluation of the training-seminar in Narva by participants - 4,9 and in Tallinn - 4,6 (see Annexes)

Every participant got a certificate on participation and education in the scope of the training programme.

Two professional trainers from NGO Living for Tomorrow (Mrs Ivanchenko and Ms Valdenmaiier) together with speakers from Ministry of Foreign Affairs of Estonia (General director of the Consular Assistance), North Prefecture (policeman managing investigation of crimes in the scope of prostitution and policemen dealing with investigation of economical crimes), European Employment Services in Estonia (consultants), and Centre of social and psychological rehabilitation for women "ATOLL" (psychologists) carried out educational process for participants (see Annexes).

The seminar program included following subjects:

- Human trafficking: definition, signs and reasons and connection with prostitution, poverty and unemployment;
- Formation of demand for sexual services in a society (advertising, media and other);
- Prostitution and human trafficking in the European legislation;
- Legal regulation of prostitution in Estonia;
- Psychological characteristic of clients of the Center ATOLL;
- Conditions of residing and work in the countries of the European Union;
- Consular assistance for citizens and permanent residents of Estonia abroad;



- Legal regulation of economic crimes in Estonia;
- Social assistance and rehabilitation of trafficked persons in Estonia.
- Providing a hotline-/ website service for (potential) victims of trafficking.

B. Developing of training-seminar materials

The project staff developed and prepared training-seminar materials, curriculum and information folders for each participant.

C. Producing informational materials

The LFT's staff developed and prepared a design of informational materials focusing on prevention of human trafficking for people going abroad and produced 1000 small informational cards in Estonian and Russian. Informational card is very convenient mean of dissemination information among people who are going abroad, both with purposes and employment, travel and education. LFT staff has spread the informational cards among participants and speakers of the seminar.

D. Cooperation and network

During project period NGO Living for Tomorrow has developed cooperation and network between authorities and NGOs in North-East and North Estonia: local governmental institutions (Ministry of Foreign Affairs of Estonia, Ministry of Social Affairs in Estonia, Office of Public Prosecutor, Police, Tallinn and Murru Prisons, European Employment Services in Estonia (EURES), NGOs and other organisations (Centre of social and psychological rehabilitation for women "ATOLL", Narva Youth Centre, Ida-Virumaa

Children and Family Support Centre, Ida-Virumaa Support Centre and Shelter for Women, Tallinn Children's Home, Tallinn Children's Protection Centre, Tallinn Institute of Humanities and Social Sciences and Mainor Business School and others) in order to increase their awareness of the problem and promote assistance to trafficked persons.

LFT has established some significant contacts with National Ministries (Ministry of Social Affairs – Ms Kristiina Luht, Ministry of Foreign Affairs – Ms Triin Hiesalu and Mr Lauri Bambus, Ministry of Justice – Ms Anu Leps) and other authorities on the governmental level; police (North Prefecture – Mr Ardo Ranne and Mr Rain Kuus) and different networks of NGOs dealing with problem of human trafficking. Living for Tomorrow arranges and strengthens the cooperation between NGOs in the European Union who are working with problems of prevention in human trafficking. Thanks the project we established new contacts with Mr Lauri Bambus, general director of consular assistance of Ministry of Foreign Affairs of Estonia and Mr Rain Kuus, head of Department for economic crimes of North Prefecture, Tallinn, who are participate in the training-seminar, as speakers.

LFT exchanged information and ideas on human trafficking regularly with the national anti-trafficking working group partners in the scope of the National Action Plan against Violence (2010-2014).

Living for Tomorrow collaborated and continue to cooperate with the *United National Office* on *Drugs and Crime (UNODC)* in Vienna. Together with UNODC the organisation develops new brochure for the European Bus network called Eurolines. We are going to elaborate awareness raising material which is going to be disseminated in the busses, sales offices from Eurolines and the bus stations. The project is focussing to provide the information of victim service provider is the 27 countries where Euroline operates.

The organisation took part in the *European project* "**E-Notes**" aims at establishing a European Union-wide permanent monitoring and reporting mechanism implemented by the European NGO community on measures against trafficking, exploitation and slavery to enhance and support public institutions' policy in the field of protection and assistance of trafficked persons.

The staffs of Living for Tomorrow also take part in the international conferences, seminars, studying meeting and establishes and develops network and cooperation between governmental institutions and non-governmental organisations on international level as well as countries of Baltic Region.

E. Dissemination of anti-trafficking information

The next component is dissemination of information on issue of human trafficking. The NGO's team provided information to journalists (Radio 4 in Narva and Tallinn). Over 750 LFT cards and 50 posters (as an in-kind support) on prevention of human trafficking were distributed during the project. Information also is disseminated on owner webpage www.lft.ee in Estonian, Russian and English.
