B: Report Narrative

Briefly restate your original goals and objectives, as stated in your proposal.
 (If objectives have changed, describe the reason for the change and the revised objective.)

Project was mainly focused on issues of domestic violence, human trafficking for purposes of labour exploitation and forced fictitious marriages. Main goal was promoting capacity building approach for improving local, national and transnational cooperation in the field, exchange of information between relevant authorities (including the civil society) responsible for victims' identification, help and assistance, prevention and prosecution of such criminal cases in Estonia.

NGO Living for Tomorrow wanted to emphasize importance of good networking and cooperation with all crucial actors, starting from legislators and law enforcement and ending with local media and foreign diplomatic missions. Project would contribute to drawing authorities' attention to gender focused violence, trafficking and promoting introduction of appropriate victim focused legislation in Estonia. On long scale, it will ensure that successful and appropriate measures against domestic violence and trafficking are being implemented both on national and local level.

During the project representatives of various local and foreign authorities shared their knowledge and experience on the topic, in order to acknowledge current trends, obstacles that inhibit reaching goals set by the National Development Plan against Violence and various international conventions.

We've planned to organize 2 roundtables in Northern and Eastern Estonia dedicated to issues of labour exploitation, followed by 2 seminars focused on exchange of existing good practices in the field.

What progress have you made toward accomplishing these original goals? Please quantify.

All planned events were successfully organized within the project frame and significantly contributed to the achievement of all established goals. It clearly strengthened motivation of all the participants and provided skills necessary for prevention of exploitation crimes, victims' assistance and identification.

We've also managed to broaden scope of the project and extend cooperation within the project.

This was displayed through following results:

- In autumn 2012 2 roundtables were organized in Narva in Tallinn. Those were first events in Estonia that were dedicated to topics of domestic violence, labour exploitation and human trafficking. Due to great interest to the events and close cooperation with Ministry of Justice and Tartu University, we've managed to extend original goal of 30 participants to 70 representatives of various institutions.
- 2 seminars dedicated to exchange of good practices and recommendations among service providers were conducted in Tallinn and Tartu.
- We've developed and updated website of NGO Living for Tomorrow <u>www.lft.ee</u>. It now contains
 information in Russian, Estonian and English on all latest achievements in the field, together with
 relevant researches and publications.
- Project helped to promote capacity building approach and continue developing networking and cooperation among local authorities and NGOs in field of human trafficking and domestic violence.

- Small evaluation meeting was organized in December 2012 and it was dedicated to assessment of the project results and possible future ventures.
- State any internal or external factors that influenced the project/program, both positive and negative. Describe actions being taken to alleviate negative factors or to sustain positive factors.

Having been given freedom to define project's content made a significant input on project's quality. As a result we've created a unique cooperation with the Ministry of Justice and Tartu University. That allowed us to bring in additional funding, extend planned activities and bring all events to higher level, involve more interested participants.

Roundtable in Narva brought together representatives of Police and Boarder Guard Board, Unemployment Board, Labour Inspectorate, Victim support and conciliation service, Prosecutor Office, Estonian Unemployment Insurance Fund, Unemployment service from bordering region of Russian Federation, Narva Social Welfare office, Ministry of Justice, Tartu University and local media.

Roundtable and seminar in Tallinn also involved mentioned institutions, together with representatives of foreign embassies in Estonia, Ministry of Social Affairs etc.

Seminar in Tartu allowed us to educate support persons for refugees and asylum seekers.

In total 95 people took place in events organized within the project scope. List of the participants and their working places are attached to the report.

What are your plans for sustaining this program or project?

Since 2004 LFT has been involved into number of activities directed at gender sensitive problems, prevention and fight against human trafficking. We are highly interested in sustaining cooperation and networking with authorities that took part in the project. During the project we've also received a proposal to organize joint event dedicated to topics covered by the roundtables from representatives of Migration Board. Such event will allow us promote cooperation among various authorities involved into implementation of National Development Plan against Violence, continue working on previous initiatives and ensure that current needs are assessed and addressed.

In November 2012, NGO Living for Tomorrow was the only representative of Baltic countries invited to deliver a speech at NORDIC CONFERENCE ON TRAFFICKING IN HUMAN BEINGS AND WORKING LIFE in Helsinki, which allowed us to present given project to more than 200 representatives of various institutions and authorities, including number of foreign media.
